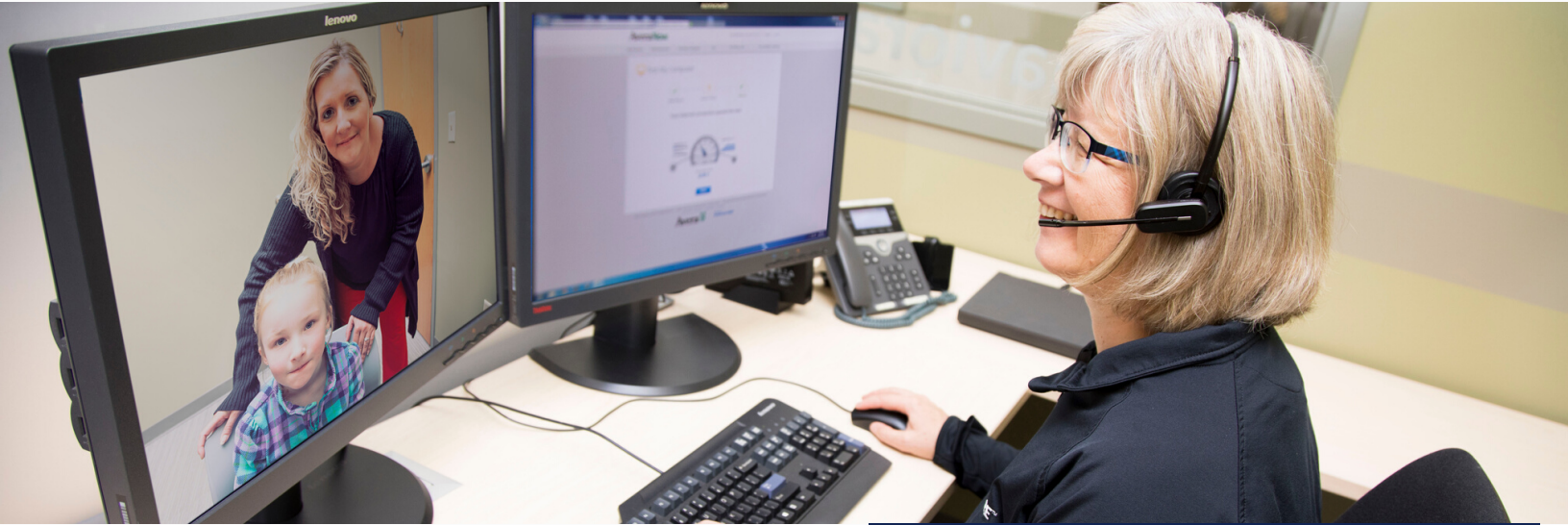


# NORTH DAKOTA eCARE SCHOOL HEALTH PROGRAM

*Improving student success by facilitating partnerships between medical professionals, home, and school.*



## PROGRAM OVERVIEW

The North Dakota eCare School Health Program was developed with the mindset of providing or extending school nursing services in an affordable manner via a telehealth (live audio/video) platform using a shared services model. The mission of the ND eCARE School Health Program is to improve access to healthcare for geographically underserved PreK - 12 ND students. Our goal is to minimize health related barriers to learning by providing safe, effective care from an experienced school nurse. According to the National Association of School Nurses (NASN), research demonstrates when chronic and acute healthcare needs are met, students miss fewer days of school and academic achievement is higher.

## WHY NOW?

Chronic physical and behavioral health conditions such as; asthma, diabetes, severe allergies, epilepsy, ADHD, depression, anxiety and substance abuse continue to increase, making it challenging to manage not only the volume of these chronic conditions, but also the complexity of the conditions. According to the 2017 Youth Risk Behavior Survey, 17.1% of ND high school and 15.7% of ND middle school students report having a long term health problem yet the ND school nurse to student ratio was 1:1,748 in 2015 despite the American Academy of Pediatrics recommendation of 1:750 (well students). Technology is a creative and fiscally responsible modality available to promote student health especially for small and rural school districts.
